IMPORTANT ITEMS: FREQUENTLY ASKED QUESTIONS

Who is covered under your membership?

- 1. You and your spouse (living in household)
- 2. Your children under the age of 18 living in the household
- 3. Once your children reach the age of 18, and they are still members of your household, they must have their own membership.
- 4. Both our insurance policy and our operating permit prohibit anyone under the age of 18 from shooting unsupervised at our facility. The supervising adult must be a current club member in good standing (meaning current dues paid and completion of the safety orientation).
- 5. As the purchasing member, it is your responsibility to ensure that all family members using the range are in compliance with safety and range rules at all times.
- 6. The CCF&G membership year runs from January 1 to December 31.
- 7. All membership fees are non-refundable.
- 8. Memberships are non-transferable

Can I bring guests to the range?

- 1. As a member, you can bring a guest to the range. However, that individual can only come to the range as a guest **once** and cannot have been a prior member. The guest must subsequently purchase their own membership should they want to utilize CCF&G facilities further.
- o Note: Prior members of the CCF&G Club, who have not renewed their membership, are not permitted to use the premises unless they are attending a club sponsored event.
- 2. Under no circumstances is your guest to visit this facility without the presence of a current member.
- 3. By bringing a guest, it is your responsibility to make sure they follow all range rules and safety regulations.

Gate

- 1. The main gate may be left open while you are using the CCF&G Club facilities.
- 2. Make certain that, if you are the first person to open the gate, you secure the gate in the full open position by attaching the rope on each side of the gate to their respective retaining poles.
- 3. If you are the last person to leave the CCF&G facilities, make sure that you lock the gate behind you.

Proof of membership

- 1. Each member will receive a membership card which will indicate the combination number to the gate lock for the current membership year.
- 2. Membership cards are issued each new membership year.
- 3. All members are **required** to have their membership card on their person whenever using the club facility. You may be approached to verify that you are a club member. If you are unable to verify your membership, you may be asked to leave.

- 1. Only the Board of Directors has the authority to close a range (or a part of a range) for scheduled events. The only exception would be for closure due to work or repairs to insure the safety of those individuals working on the range.
- 2. All other closures must be approved by the Board of Directors.
- 3. All shooters must shoot from the designated firing lines on all ranges. Moving forward of the firing line to shoot, on any range, constitutes a closure of the range and is prohibited without Board of Director approval.
- 4. You will find information on range scheduling and closures on the CCF&G web page at www.ccfandg.org, in Club Newsletters and posted outside the Clubhouse.
- 5. If there is a scheduled high power rifle event, the schedule will indicate whether it is a 200 or 300 yard event and the start and end time. If the event is scheduled for the 300 yard range, any range forward of the 300 yard line will be closed.
- 6. Start and end times for scheduled events are "approximate" times and may vary based on number of participants, etc.
- 7. Scheduled programs that require some or all ranges to be closed are:
- High power rifle events, Jr. small-bore practice, recreational pistol (2nd Saturday of every month). hunter safety field work, cowboy events, Women On Target, African shoots, and Law Enforcement training weeks (always during week-days)
- 8. All of these events (except Law Enforcement training) are open to the public and are significant sources of revenue for the Club. The revenue generated from these programs, along with significant member volunteer work, are among the reasons for our ability to continue to offer membership at very reasonable rates.

We need you to keep this facility safe and open for all.

- 1. In order to keep this facility open for all to enjoy, we must keep it safe.
- 2. It is important that each member take an active part in this process.
- 3. CCF&G requires a safety orientation because there have been occasional (one is too many) occurrences of unsafe practices.
- 4. If a member observes an unsafe act, bring the unsafe act to the attention of individual/s involved and, if necessary, record their license plate number and report them to any Director listed on your membership card.

Swinging Targets

- 1. The club has installed "swinging targets" at the 100, 200 yard and Pistol Range impact areas.
- 2. Specifically approved targets by the Board of Directors are the only non-paper targets allowed outside of a sanctioned event.
- 3. The Pistol Range swinging targets are not to be moved from their location at the bottom of the impact berm.

Safe firearm handling

1. The Board of Directors has defined basic rules that apply in all shooting conditions:
☐ All firearms must be in control at all times. This includes handling and actually firing.
☐ All firearms must be pointed in a safe direction at all times.
☐ All firearms are to remain unloaded until ready to fire.
☐ All fingers must be off triggers until ready to fire.
☐ Firearms must be unloaded, actions open, and absolutely no handling of firearms when people are down range.
☐ All rounds fired on the rifle and pistol ranges must directly strike the impact berms.
