



Farms and Firearms

Farms and firearms have been married since the first musket was born. The firearm has provided security, food, and money for farmers, homesteads, trappers, and journeymen of all kinds. Today's small farms and homesteads are just as reliant on firearms for protection against predictors, supplying wild game for the table and for processing larger farm animals. Firearms for protection against poachers is not as significant a threat as it once was. Still, with today's society, one never knows.

In today's world, there are hundreds of choices of firearms in a variety of calibers. Each person seems to have their own go-to firearm and caliber as their specific needs require. Some people carry a sidearm, some prefer a long gun, some prefer rifles, and some prefer a shotgun. Particular needs are based on location, laws, terrain, and just plain old personal preference. Ask the dumb questions, don't be afraid to not be in "the know." Find firearms reviews as you narrow down your search and test as many firearms as you need to find your one, two, or three. Most importantly, please educate yourself on the safe use of your firearm and become proficient with it. Seek out instruction from trainers and manufacturers reps. Shoot and shoot and shoot some more, and when you are absolutely comfortable and proficient... shoot some more. Someday, a life may depend on your firearm being second nature to you.

I have been looking for the "perfect homestead "gun as my go-to that covers every need I'll have, and I'm not sure they make one. The closest gun I could find for my specific needs is the Savage model 24 combination rife/shotgun, chambered in .223/12 gauge. It's 99% of what I need, except that it's a little challenging to put on my belt loop and carry it into town. So I have a subcompact sidearm chambered in .45 ACP that I take. There are limitations to my choice of weapons, but they are a perfect match for my real-world application.

So remember to identify first what your specific needs currently are and what they may be in the future. Identify what firearm or arms fill your particular needs. Educate yourself as a functional, safe user and owner.
